2. PRIVACY POLICY

Data controller – NCSR Demokritos is the “data controller” of all the above personal information (gender, name, surname, affiliation, company, email) collected from you and used for the purposes explicitly identified below. Uses of Personal Data of Participant - The personal data that we collect are strictly and exclusively the following ones: gender, name, surname, affiliation and e-mail. By signing this form **you explicitly give your consent** to collect and use your personal data for the following purposes. Article 6 (1) (a) of EU GDPR is the legal basis for the processing of personal data (consent of the data subject) :

- a. we use the information you give us for registration purposes of the event ;
- b. we use the information for contacting you with information regarding the event and the project in general. You will have the choice to **opt in or opt out** of receiving such communications by indicating your choice at the email.
- c. Security, health, administrative, crime prevention/detection: we may pass your information to government authorities or enforcement bodies for compliance with legal requirements; if processing is necessary to safeguard legitimate interests of our project , the legal basis is article 6 (1) (f) of EU GDPR.

Personal Data Retention - We will not retain your data for longer than is necessary to fulfil the purpose it is being processed for. To determine the appropriate retention period, we consider the amount, nature and sensitivity of the personal data, the purposes for which we process it and whether we can achieve those purposes through other means.

When we no longer need your personal data, we will securely delete or destroy it. We will also consider if and how we can minimise over time the personal data that we use, and if we can anonymise your personal data so that it can no longer be associated with you or identify you, in which case we may use that information without further notice to you.

Security of your Personal Data - We follow strict security procedures in the storage and disclosure of your personal data, and to protect it against accidental loss, destruction or damage.

Your Data Protection Rights –Under certain circumstances, by law you have the right to:

- **Request information** about whether we hold personal information about you, and, if so, what that information is and why we are holding/using it.
- **Request access** to your personal information (commonly known as a "data subject access request"). This enables you to receive a copy of the personal information we hold about you and to check that we are lawfully processing it.
- **Request correction** of the personal information that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- **Request erasure** of your personal information. This enables you to ask us to delete or remove personal information where there is no good reason for us continuing to process it.
- **Request the restriction of processing** of your personal information. This enables you to ask us to suspend the processing of personal information about you.
- **Request transfer** of your personal information in an electronic and structured form to you or to another party (commonly known as a right to "data portability"). This enables you to take your data from us in an electronically useable format and to be able to transfer your data to another party in an electronically useable format.
- **Withdraw consent.** When our use of your personal data is based on your consent, you have the option to withdraw your consent to our processing and delete your personal data at any time by sending us an email at edoukoudaki@iit.demokritos.gr. Once we have received notification that you have withdrawn your consent, we will no longer process your information for the purpose or purposes you originally agreed to, unless we have another legitimate basis for doing so in law.
